For a Credit Transfer (CT) application of same or equivalent units of competency, this Form must be accompanied by originals of your nationally recognised Certificates and/or Statement of Attainments and/or an authenticated USI transcript Originals, with detail indicating the units successfully completed including unit codes and titles and dates of completion of these documents must be signted by a NITA representative, who will also verify the certification with the issuing training provider. There is no service fee for CT applications.
